## Contract/Payment

Contracts must be submitted \& paid online (chaskafsc.com) by 2/17/2024 in order to avoid a late fee ( $\$ 5$ per day up to $\$ 25$ ). The due date and late fee apply to all sessions including Aspire sessions.

## Terminology Key:

Program = a club ice session held weekly throughout the quarter
Session $=$ one meeting time within a program (either 45-60 minutes)

## Discounts:

Club program discounts are applied as follows:
Register for 20-40 sessions, receive a $20 \%$ discount
Register for 41 or more sessions, receive a $33 \%$ discount
Choose All You Can Skate and pay a total of $\$ 588$ for the quarter
Choose Aspire All You Can Skate and pay $\$ 495$ for the quarter

## Payment:

When you register online, you can choose to pay in full or in 3 installments. The installment will be due on the 15 th of each month. All payments will be made online by $\mathrm{CC} / \mathrm{ACH}$.

## Membership:

Skaters who do not renew their membership for the 2023-24 skating year will be billed at non-member rates beginning 7/1/2023.

## Contract Changes:

Contract changes are allowed through 3/16/2024. Email chaskafigureskatingclub@gmail.com to make changes.

Home Club Members may switch times missed within the same quarter of the missed session. If a session is missed in the last month of a contract, the missed session may be made up within the first week of the next quarter. There are no refunds for missed sessions. Skater or a parent is responsible to communicate the trade to the rink monitor (or write it in the book if there is no rink monitor).

## Skating Recommendations/Requirements

## How Many Sessions to Contract:

The goal and purpose of our club is to encourage the instruction, practice, and advancement of our figure skaters. With that goal in mind, below is a "rule of thumb" chart for the amount of ice sessions an average skater could contract to advance to the next test level:

- Skate School/Freestyle Levels: 2 to 3 programs/week(includes skate school)
- Pre-Preliminary: 3 to 4 programs per week
- Preliminary - Pre-Juvenile: 4 to 5 programs per week
- Juvenile to Senior: More than 5 programs per week


## Ice Show Qualification:

Skaters must contract to skate at least 30 sessions per quarter to be eligible for a solo, duet or trio in the annual ice show. See the handbook for full eligibility information.

## Lettering:

Skaters wishing to letter must skate a total of 150 hours (200 sessions) per school year (June 1 - May 31). Other requirements are listed in the lettering packet.

## Rink Monitoring:

Rink Monitor sign-up will be done through Sign-up Genius. All contracted families (including Home Club, Aspire Introductory, Aspire, Associate, Reciprocal, Collegiate, etc.) will have a rink monitoring requirement. The number of sessions will be detailed on the Rink Monitor Sign-up information that will be sent out before the registration opens.

If you cannot rink monitor, or choose not to, you may buy out of your rink monitoring duties. There is an initial fee for the first skater in a family, and an additional fee for each additional skater in a family. The fees are as follows:

- For those whose rink monitor requirement is 5 or more sessions, the buy-out fee is $\$ 120$ for the first skater, and $\$ 20$ for each additional skater in a family.
- For those whose rink monitor requirement is 3 or 4 sessions, the buy-out fee is $\$ 60$ for the first skater, and $\$ 20$ for each additional skater in a family.
- For those whose rink monitor requirement is 1 or 2 sessions, the buy-out fee is $\$ 40$ for the first skater and $\$ 20$ for each additional skater in a family.

Assigned rink monitors who fail to show up and don't arrange for coverage will automatically be billed $\$ 15$ for each session missed. If you miss 3 or more rink monitor shifts, or all of your rink monitor shifts if your requirement is only 1-2, within the same contract period, you will be assessed the full buy-out fee for that quarter.
